COMMUNITY REPRESENTATIVE RESOURCES

The information below can be shared with residents to raise awareness about the consultation among your communities.

NAV CANADA is currently conducting a trial of alternate headings for aircraft departing in a southerly direction at Calgary International Airport (YYC). Through increased overflight of non-residential land, the trial is anticipated to reduce the cumulative community noise exposure for many communities south of the airport, while ensuring a safe and efficient operation.

As part of the trial, NAV CANADA is hosting public consultations from January 24 to March 11. Two online information sessions have been scheduled in February and March to ensure communities near the airport have the opportunity to learn more about the trial and provide input before any change is made permanent.

QUESTION & ANSWER

Q: Would it be possible to modify the flight path in a way to have planes fly over industrial areas longer rather than over residential areas?

A: The distance between two parallel runways means flights need to fly along that path. Changes to that specific flight path are not considered as part of this trial but could potentially be considered in future trials.

Q: How can community associations help inform residents about the NAV CANADA consultation?

A: NAV CANADA is leading the communications and awareness. There are no expectations of people on this call to educate anyone on the trial. NAV is targeting communities directly south of the airport as this trial affects those communities but passing to as many communities south of the airport as possible.

Q: Will this be shared with city councillors?

- NAV CANADA reached out to elected officials at all three levels of government.
- Federation of Calgary Communities offered to add trial details in their bi-weekly newsletters to connect to more communities.

Q: Is there a map of flight movement statistics similar to the passenger statistics?

A: The number of movements also dropped significantly in 2020 and 2021.
