

[The “LONG” Rules]

THE CALGARY AIRPORT AUTHORITY (KNOWN AS CALGARY AIRPORTS) STANDARD CONTEST RULES

(The “Rules”)

These rules govern the contests and giveaways (collectively, the “Contests,” each a “Contest”) administered by Calgary Airports. The Contests are conducted in the Province of Alberta and are subject to applicable municipal, provincial, and federal laws, including the *Competition Act* (Canada) and the *Alberta Personal Information Protection Act* (PIPA).

No purchase is necessary. Contests are void where prohibited by law. Participation in a Contest constitutes acceptance of these official Contest Rules (the “Rules”).

Selfies at Security: Centralized Security Social Contest

1. ELIGIBILITY

To be eligible to enter the Contest, an individual must:

- Be a legal resident of Alberta and have reached the age of majority (18 years or older); and
- Be the sole owner of any content submitted in connection with the Contest (see 3(a)(1), the “Work”).

Employees, officers, directors, representatives, and agents of Calgary Airports, its parent, related and affiliated companies, subsidiaries, departments or agencies, franchisees, suppliers, advertising and promotional agencies, contest administrators, and any other parties engaged in the development, production, or distribution of Contest materials, and those living in the same household, whether related or not, are not eligible to enter this Contest. By participating in this Contest, entrants acknowledge compliance with, and agree to be bound by, these Contest Rules. Entrants who do not comply with any and all of the Contest Rules are subject to disqualification by Calgary Airports, in its sole discretion.


Facebook and Instagram are not sponsoring or endorsing this contest.

2. CONTEST PERIOD

The Contest entry period (the “Contest Period”) will begin on December 18, 2025, 7 a.m. MST and will end on January 29, 2026 11:59 p.m. MST, after which time the Contest will be closed and no further entries will be accepted.

3. HOW TO ENTER

(a) No purchase necessary. To enter:

1. Take a photo at the mirror selfie station.
2. Follow and tag @Fly_YYC. 
3. Use hashtag #SimpleSecurityYYC And post on Facebook, Instagram, LinkedIn, Twitter (grid posts). Instagram & Facebook stories count as additional entries.

Your social media accounts must be set to “public” to qualify.

(b) Entry Limit: There is a limit of one (1) entry per person per Contest Period. Additional entries will be void.

(c) Entry Ownership: All entries become the property of Calgary Airports and will not be returned. Late, illegible, incomplete, damaged, fraudulent, or otherwise invalid entries will be disqualified.

(d) Submission of Work: If applicable, by submitting Work in connection with the Contest, the entrant represents and warrants that:

- The Work is original and does not infringe upon any third-party rights.
- Calgary Airports may use the Work for promotional purposes across media platforms.

(e) Online Entries: Entries submitted online will be deemed to have been submitted by the authorized account holder of the social media or email account associated with the entry.

Any attempt or suspected attempt to use robotic, automatic, programmed, or otherwise illicit means to enter the Contest, or any other methods not authorized by these Contest Rules, including but not limited to creating multiple accounts, identities, or registrations, all in Calgary Airports’ sole discretion, shall be deemed as tampering and may disqualify the entrant from entering, participating, and/or winning the Contest Prize. Entries that contain false or incomplete information are void. Entries that are late, lost, stolen, illegible, damaged, misdirected, mutilated, garbled, or otherwise irregular, or that do not conform with or satisfy any or all of the conditions of the Contest Rules, are void. Entrants grant Authority a non-exclusive, irrevocable license to use all entries for any purpose. No correspondence will be entered into except with selected entrants. Proof of transmission (e.g., screenshots or captures) does not constitute proof of entry or receipt of an entry.

4. PRIZES

(a) Number of Prizes

There is one (1) prize available to be won (the “Prize”) and consists of:

- WestJet (“Contest Sponsor”): Two (2) roundtrip economy airfares from Calgary, Alberta on a regularly scheduled, marketed and operated WestJet flight, within Canada.
- No cash value. Fees, taxes, and surcharges for the Prize will be covered by Calgary Airport. Blackout dates and other restrictions apply – see section 6 for Prize rules. All Prizes valid for travel until December 15, 2026.

(b) Prize:

- Approximate value of \$2,200 CAD

(c) Prize Conditions:

- Prize is non-transferable and cannot be sold, refunded, or exchanged for cash
- Prize cannot be combined with other discounts, promotions, or special offers.
- If unavailable, Calgary Airports reserves the right to substitute the Prize with a prize of equal or greater value at its sole discretion.

(d) Prize Distribution: The winner will be contacted with instructions on how to claim the Prize. Calgary Airports is committed to distributing the Prize without undue delay, in compliance with the *Competition Act* (Canada).

(e) Authority's Liability: Calgary Airports is not responsible for loss, damage, or misdirection of the Prize.

5. WINNER SELECTION

(a) Odds of Winning: The odds of winning depend on the number of eligible entries received before the Contest End Date.

(b) Winner Selection Process: A random draw will be conducted on January 30, 2026, 11:59 p.m. MST at 2000 Airport Road NE, Calgary, Alberta. If a selected entrant does not meet eligibility criteria, another entrant will be drawn.

(c) Winner Requirements: Selected entrants must:

1. Correctly answer a skill-testing question.
2. Sign and return the Declaration of Eligibility and Liability/Publicity Release form.
3. Comply with all Contest Rules.

(d) Notification: The winner be contacted via telephone and email within [2] business days. If unreachable after three attempts, another entrant may be selected.

(e) Verification: Calgary Airports reserves the right to verify the identity and eligibility of any entrant at any time. Failure to provide such proof may result in disqualification.

6. WESTJET TERMS AND CONDITIONS

Estimated potential retail value: \$2,200 CAD. Without limiting the generality of the foregoing, the following general conditions apply to the Prize: (i) Prize must be accepted as awarded and is not transferable, assignable and/or convertible to cash (except as may be specifically permitted by Contest Sponsor in its sole and absolute discretion); (ii) no substitutions are permitted except at Contest Sponsor's option; (iii) the costs of everything not expressly and specifically stated above as included in the Prize are the sole and absolute responsibility of the confirmed winner; (iv) if the confirmed winner

does not utilize any part(s) of the Prize, then any such part(s) not utilized may, in the sole and absolute discretion of the Contest Sponsor, be forfeited in their entirety and, if forfeited, nothing will be substituted in their place; (v) Contest Sponsor reserves the right at any time to: (a) place reasonable restrictions on the availability or use of the Prize or any component thereof; and/or (b) substitute the Prize or a component thereof for any reason with a prize or prize component(s) of equal or greater retail value, including, without limitation, but solely at the Contest Sponsor's sole discretion, a cash award; and (vi) by accepting the Prize, the confirmed winner agrees to waive all recourse against the Contest Sponsor and all of the other Released Parties if the Prize or a component thereof does not prove satisfactory, either in whole or in part. **Additional Prize conditions, if any, provided by the Prize Supplier are included below in Schedule "A" to these Rules.**

WestJet Prize Voucher:

The WestJet Voucher (the "**WestJet Voucher**") is valid for one (1) roundtrip flight for two (2) guests in Economy on a regularly scheduled, marketed and operated flight from Calgary, Alberta to a regularly scheduled, marketed and operated flight within Canada, and is subject to the following conditions (as specified by WestJet):

- Fees, taxes and surcharges are the responsibility of Calgary Airport to be paid for at the time of booking with a valid credit card. Your exclusive WestJet Voucher number is valid on a regularly scheduled WestJet marketed and operated flight from Calgary, Alberta, with regularly scheduled, operated and marketed service within Canada. The WestJet Voucher does not include optional fees such as checked baggage or eligibility for any cabin upgrades. Please book early to maximize your flight options. Destinations outside of Canada are not eligible for the Prize.
- The WestJet Voucher is limited and subject to promotional Economy space, availability of eligible fare options and flight schedule. Not all flights have promotional Economy space. The WestJet Voucher is not valid for redemption on WestJet Vacations' packages, flights operated by Sunwing, interline, code share or charter flights.

- The WestJet Voucher is valid for one (1) roundtrip flight for two (2) guests from Calgary, Alberta with regularly scheduled, operated and marketed service within Canada. All guests must travel together on the same itinerary, dates and flights.
- Flights must be roundtrip to and from the same locations. Flights must depart from city A to city B and return from city B to city A.
- The WestJet Voucher cannot be used on some dates, including statutory holidays and peak travel dates. Blackout dates: February 12-16, March 12-16, 19-23, 26-30, April 2-6, May 14-16, 18, June 25 - July 1, July 30 - August 3, September 3-7, 28-30, October 8-10, 12, November 6-11, 2026. Other restrictions may apply.
- All bookings and travel must be completed by the expiry date indicated on the WestJet Voucher. December 15, 2026.
- The WestJet Voucher cannot be extended. Additionally, changes to travel dates or guest names are not permitted once a booking has been confirmed.
- Bookings made with the WestJet Voucher are not eligible for paid upgrades.
- The WestJet Voucher becomes null and void if travel is cancelled once a booking is confirmed.
- The guests booking the flight must be over the legal age of majority in their jurisdiction of residence.
- The WestJet Voucher must be taken as offered and is not redeemable for cash.
- The WestJet Voucher cannot be sold. In the event that it has been sold, the WestJet Voucher will become null and void, and any flight bookings made with it will be cancelled immediately without notice or reimbursement. WestJet does not handle the payment, guarantee transactions, or buyer protection or seller certification, nor will WestJet be liable for the loss of funds resulting from a fraudulent transaction.
- Guests travelling on WestJet gift of flight voucher are not entitled to compensation amounts provided under passenger rights regimes. By redeeming this voucher, all guests travelling agree to release, and waive all claims against, WestJet relating to any and all liability, damage, or compensation entitlement arising under Canada's Air Passenger Protection Regulations.
- WestJet and the other Released Parties are not responsible for lost or mishandled vouchers. Once the WestJet Voucher has been delivered to you, you are directly responsible for it

Without limiting the foregoing, the following additional terms and conditions also apply:

- The confirmed winner and his/her guests are responsible for transportation to and from the gateway airport and all other expenses not expressly stated as included herein.
- Transportation is subject to availability, blackout periods, government restrictions and regulations, airline, airport or other transportation restrictions and regulations. The winner and his/her guest are responsible for all expenses other than those mentioned above as included including, but not limited to, other transportation, attractions, merchandise, souvenirs, travel insurance, travel visas and all other personal expenses of any kind. None of the Released Parties are responsible for, nor accept any liability

whatsoever in relation to, any delay, postponement, suspension, rescheduling or cancellation, for any reason, of any flight(s) and neither the winner nor any other person or entity will be compensated in the event of such delay, cancellation or other event described herein. Other restrictions may apply.

- The WestJet Voucher is non-transferable and without limiting the foregoing, the WestJet Voucher may not be sold or traded, the WestJet Voucher must be taken as offered and cannot be substituted, redeemed or exchanged for cash, credit or alternative prizes, except in the Prize Suppliers sole discretion. WestJet reserves the right to substitute the WestJet Voucher with a prize of equal or greater value. No credit or reimbursement will be provided if the WestJet Voucher is not utilized in full. The WestJet Voucher cannot be combined with any other promotional offer or offers provided by WestJet.
- The WestJet Voucher is subject to all of the terms and conditions as stated by WestJet and will be delivered to the confirmed winner directly from the Contest Sponsor to the address/email address provided after the potential winner has been successfully contacted and notified of his/her Prize and has fully complied with the Rules (as determined by the Contest Sponsor in its sole and absolute discretion). Shipped Prizes shall not be insured and neither Contest Sponsor nor any of the other Released Parties shall assume any liability whatsoever for a lost, damaged, or misdirected element of the Prize. The WestJet Voucher has a maximum potential retail value of \$2,200 CAD – although the actual value will depend on the destination chosen and time of booking from originating city. Under no circumstance whatsoever will any difference between the actual and approximate retail values be awarded.

7. RELEASE & INDEMNIFICATION

By entering the Contest, each entrant:

- Releases and holds harmless Calgary Airports, Contest Sponsor, and their affiliates from any liability arising from participation in the Contest or use of the Contest Prize.
- Agrees to indemnify Calgary Airports against any claims related to their entry.
- Grants Calgary Airports a worldwide, irrevocable license to use the Work for promotional purposes.

8. LIMITATION OF LIABILITY

Calgary Airports and Contest Sponsor are not responsible for:

- Technical malfunctions or errors affecting the entry process.
- Lost, late, or misdirected entries.
- Any injury or damage resulting from Contest participation or use of the Contest Prize.

If the Contest cannot be conducted as planned due to fraud, technical issues, or unforeseen circumstances, Calgary Airports reserves the right to cancel, suspend, or modify the Contest.

9. PRIVACY & USE OF PERSONAL INFORMATION

By entering, participants consent to Calgary Airports using their personal information for:

- Contest administration (including contacting winners).
- Publicity and promotional purposes.

Calgary Airports will handle all personal information in accordance with Alberta's *Personal Information Protection Act (PIPA)* and its privacy policy.

10. GOVERNING LAW

The Contest is void where prohibited by law and is subject to all applicable Canadian federal, provincial, territorial, and municipal laws. The Contest shall be governed exclusively by the laws of the Province of Alberta. Any dispute shall be adjudicated in the courts of Calgary, Alberta.

11. INTELLECTUAL PROPERTY

All intellectual property associated with the Contest is owned by Calgary Airports. Unauthorized use is strictly prohibited.
