
## NOISE PROFILE AND OPERATIONAL UPDATE



#### Refining airport facility use and operations

- Centralized deicing
  - Improves deicing fluid usage
  - Reduces GHG emissions
  - Improves operational efficiency
  - Optimizes the glycol recycling and treatment facilities
- #FlyHealthyYYC
  - Ensuring we can make the experience as safe as possible for travelers to/from Calgary
  - Modifying check-in and passenger movement in the terminal
  - International screening pilot






#### Refining airport facility use and operations

  - YYC, NAV and Operators will begin planning for peak operations in summer






#### **Runway Usage October to December 2020**









#### **Average Movements/Hour**






### Household Noise Concerns by Community


## **OVERVIEW**

Calgary Tower in collaboration with the Calgary A procedures that are intended to:

- > Deliver noise mitigation to communities south of the airport
- > Respond to airport infrastructure changes
- Improve air traffic management during high demand periods (or, as in this past year has been low traffic demand)

Calgary Tower in collaboration with the Calgary Airport Authority is currently trialing new departure

## **17R JET DEPARTURES** Summary Statistics – October to December



Tracks for turn-eligible flights: December 1<sup>st</sup> to December 8<sup>th</sup> , 2020.

- > 1,745 jets departed off of 17R in total
- > Of these, 51% or 896 departures, were eligible to turn to a heading of 135°:
- > 45% of total departures (779 departures) turned to a heading of 135°



Tracks for turn-eligible flights: October 1<sup>st</sup> to December 31<sup>st</sup> , 2020.

**715 jets** departed off of 17L in total Df these, **9%** or **63 departures**, were eligible to turn to a heading of 35°:

5% of total departures (34 departures) turned to a heading of 85°

### BENEFITS

#### **Environmental**

Increased noise distribution for departures and ability to distribute regardless of runway in use.

Departures from 17R more likely to overfly non-residential use land at lowest altitudes

Departures from 17L more likely at a greater altitude when they reach residentially populated areas

Reduced greenhouse gas emissions as a result of reduced taxiing and more direct routing

	Operational
eS,	Reduced complexity in moving aircraft on the ground and reduced active runway crossings
ly es	Consistency for the controller in allowing the same techniques to be applied in either flow (north/south).
	Improved utilization of changes to ground infrastructure
£	Increased ability to move traffic in a timely manner during peak periods

## **TRIAL – KEY CONSIDERATIONS**

- Trial format provides an opportunity to assess the benefits to the communities intended 1 year trial (due low traffic it has been extended to the end of 2021)
- > Initial briefing to the airport's community consultative committee (ACCC) provided on September 18<sup>th</sup>
- > A public notice was published on the airport's website and shared with YYC's email distribution list
- > Committed to updating the ACCC on performance of the trial at scheduled meetings (4x/year)
- > Your feedback is welcomed
- As the trial has been extended, further public engagement/consultation will be conducted in coordination with the Calgary Airport Authority (expect an information on the plan at the next ACCC)
