- 1. The pass issued to me is the property of the Calgary Airport Authority and will be:
 - a) surrendered by me:
 - I. on demand of the Calgary Airport Authority;
 - II. on demand of a Peace Officer or Airport Security Personnel.
 - b) returned to the Pass Control Office of the Calgary Airport Authority:
 - I. on or before the expiry date on the face of this certificate;
 - II. immediately upon termination of my employment at Calgary International Airport or other circumstances under which I was issued a pass;
- 2. The pass issued to me is only valid for those restricted areas to which I require access while I am on duty or in the performance of functions directly related thereto.
- The pass issued to me is not to be used to bypass passenger pre-board screening where, as an intended passenger on a commercial aircraft, I would be subject to such screening.
- 4. The pass issued to me is subject to the limitations and restrictions set out on the face of the pass and to any other limitations issued to me in writing by the Calgary Airport Authority.
- 5. The pass issued to me is to be worn on the outer clothing on the left or right side of the chest, or on the outer left or right upper arm when the chest location interferes with my ability to work, with the front of the pass visibly displayed.
- 6. As a pass holder, I will safeguard the pass issued to me at all times.
- I have been informed of and am subject to any fees associated with the administration of the pass system. Fees are subject to change at the discretion of the Calgary Airport Authority.
- I am subject to the requirements of the Aerodrome Restricted Area Access Clearance Program including the requirements for escort or other security controls, where necessary.
- 9. I certify that Transport Canada has neither refused to grant a clearance to me nor suspended or cancelled my security clearance.
