

# Airside Vehicle Operator's Permit (AVOP) Application

*Complete both pages of the application form for ALL AVOP applications (New, Renewal, Change of Employer & Second Employer):*

All AVOP applicants must bring the completed AVOP Application form, a signed printout of their test certificate, their valid Driver's License & RAIC when applying for an AVOP. D and D-TT AVOP applicants must bring their ROC-A and AME licenses (if applicable).

## *Competency Check / Night Endorsement:*

Competency Check / Night Endorsement Assessments must be completed no sooner than 30-days but within 180-days of completing the Practical Assessment. Failure to complete the Competency Check / Night Endorsement within the required time limit shall result in the AVOP being cancelled.

## *Renewal:*

All requirements must be completed & submitted to the AVOP Office prior to expiry of the current AVOP. Renewal requirements, if completed prior to expiry, including issue of a new AVOP card, are DA, DA-WS: written assessment only; D, D-TT: written and practical assessment.
